GUIDELINES for PARTIES at the POOL / PARK

A pool party is defined as a resident who brings a group of five (5) to twenty (20) guests inside the pool area together, whether swimming or not. You may not have more than twenty (20) guests at your pool party.

□ You must notify the Head Monitor at least one-week in advance by turning in a <u>Pool Party Request Form</u> (below) if you want to have any group of five (5) or more guests at the pool.

U We need to know the date, number of people, and the time of your gathering so we can take appropriate action to be ready.

□ The Head Monitor will not schedule more than one group party on the same date. No group parties will be permitted on holidays, Board meeting days, or other days that are expected to be unusually crowded at the pool.

□ No BBQ's inside the gated pool area. BBQ's must be out on the lawn, at least 10-feet away from the fence.

□ No pop-up shades inside the gated pool area. Pop-ups must be out on the lawn.

□ No ALCOHOL of any kind is allowed inside the fenced pool area. No glass containers. No ceramic food containers

u You must bring your own trash bags. All trash must be hauled away when you leave and not put in the Pool trash bins.

□ You must limit your guests from going in and out of the gate excessively.

□ If you are going to rent an inflatable jumper, you must supply a generator to power it. You cannot plug into the pool electricity due to hazards from cords.

□ If you have children under age 14 inside the pool area, there must be a supervising adult (minimum 18 years old) inside the fenced pool area with them at all times. Watching through the fence is not acceptable. There shall be one (1) supervising adult to every four (4) children under the age of 14 inside the fenced pool area at all times.

□ All swimmers must shower before they enter either pool.

u Young children still in diapers must use plastic pants or the "Swimmers" type diaper. No baby diapers are allowed in the pools.

□ Children's clothing/diapers must be changed inside the bathroom, not at poolside and not in the shower area. No nudity is allowed. No showering nude is allowed. This applies to all ages, including children and babies.
