

MESA VIEW HOA#2 POOL RULES

Pool rules are also posted on the bulletin board in the pool area and on our website.

1. Use of the pool/park facilities is expressly limited to homeowners or their legal tenants residing on the premises in the Mesa View HOA#2. Up to four (4) invited and supervised guests per family are allowed and must be accompanied by an adult member of the household (18 years or older). Homeowners are responsible for the conduct of their guests.
2. Admittance to the pool enclosure is restricted to members only and accompanied guests. Our key card is required for admittance. All others will be considered uninvited and subject to arrest for trespassing. Each resident should have a Pool Registration Form on file.
3. Children under age fourteen (14) are not allowed inside the pool enclosure without adult supervision (18 years or older) accompanying and assuming responsibility and liability for them.
4. Children under age five (5) may use the small pool when accompanied by a supervising and responsible adult (18 years or older). Children not completely potty trained must wear a cloth diaper with rubber pants or suitable pool style disposable swim diapers. Diapers must be manufactured for pool use. Regular diapers are not allowed. Please be discreet when changing your children at the pool.
5. The established park and pool hours are from 10AM to 10PM during summer hours and from 10AM to 6PM during winter hours. If specifically requested, you may have access to the pool for "Early Morning Swim" beginning at 5:30AM.
6. All health, penal, and municipal codes and laws must be obeyed. Members or guests refusing to obey the rules and laws will lose their pool and park privileges for thirty (30) days for each infraction. Members will be billed for any damage for which they are responsible.
7. No animals of any type are allowed in the pool enclosure, other than working animals for the blind and disabled. Repeat offenders will be prosecuted under San Diego County Animal Regulations.
8. Food, gum, alcoholic beverages, glassware, narcotics, marijuana, all illegal substances, profanity, littering, and all organized team spots are strictly prohibited in the pool enclosure. Anyone under the influence of in possession of alcohol or illegal substances will be prosecuted to the full extent of the law - No Exceptions.
9. All personas must shower prior to entering either pool. A shower facility is provided on the premises.
10. All persons with hair that touches their shoulders when wet must have hair braided, in a ponytail, or placed under appropriate swim cap attire. Hairpins, barrettes, clips, curlers, etc. are strictly prohibited inside the pool enclosure. (They can damage the pool filters.)

11. Only appropriate swim attire is allowed (i.e. swimsuits); no street clothes. Un-hemmed cutoffs are prohibited. Clean white T-Shirts may be worn in the water with the approval of the Pool Monitor prior to use.
12. Running, pushing, dunking, horseplay, loitering, or any inappropriate behavior as determined by pool monitors is strictly prohibited.
13. Styrofoam floats, boogie boards, inner tubes, Frisbees, surf-mats, surfboards and any Nerf type items are prohibited. Balls, pool toys, floats, fins and certified SCUBA masks are permitted during slack hours when permitted by the Pool Monitors.
14. Use of the pool facilities during thunder or lightning is very dangerous and strictly prohibited. For your safety, you must leave the pool area at once during these times.
15. Nuisance devices, such as air horns, boom boxes and other loud noise making devices are prohibited. Good common sense should be used when in the pool or park area. Be conscientious and courteous.
16. Topless or nude swimming or sunbathing is prohibited.

PLEASE NOTE:

Use of the pool facilities by yourself or with guests is at your own risk. The Association assumes no liability for accidents and injury at any time.

Pool privileges will be suspended (your electronic key card will be disabled) if Homeowners dues are not current. You must be a member in good standing to use the pool.

These rules have been written for the comfort, enjoyment and safety of all members and their guests. Please observe all rules and make everyone's stay enjoyable.
